### **CURRENT MEYERLAND PVA/HISD STUDENTS**

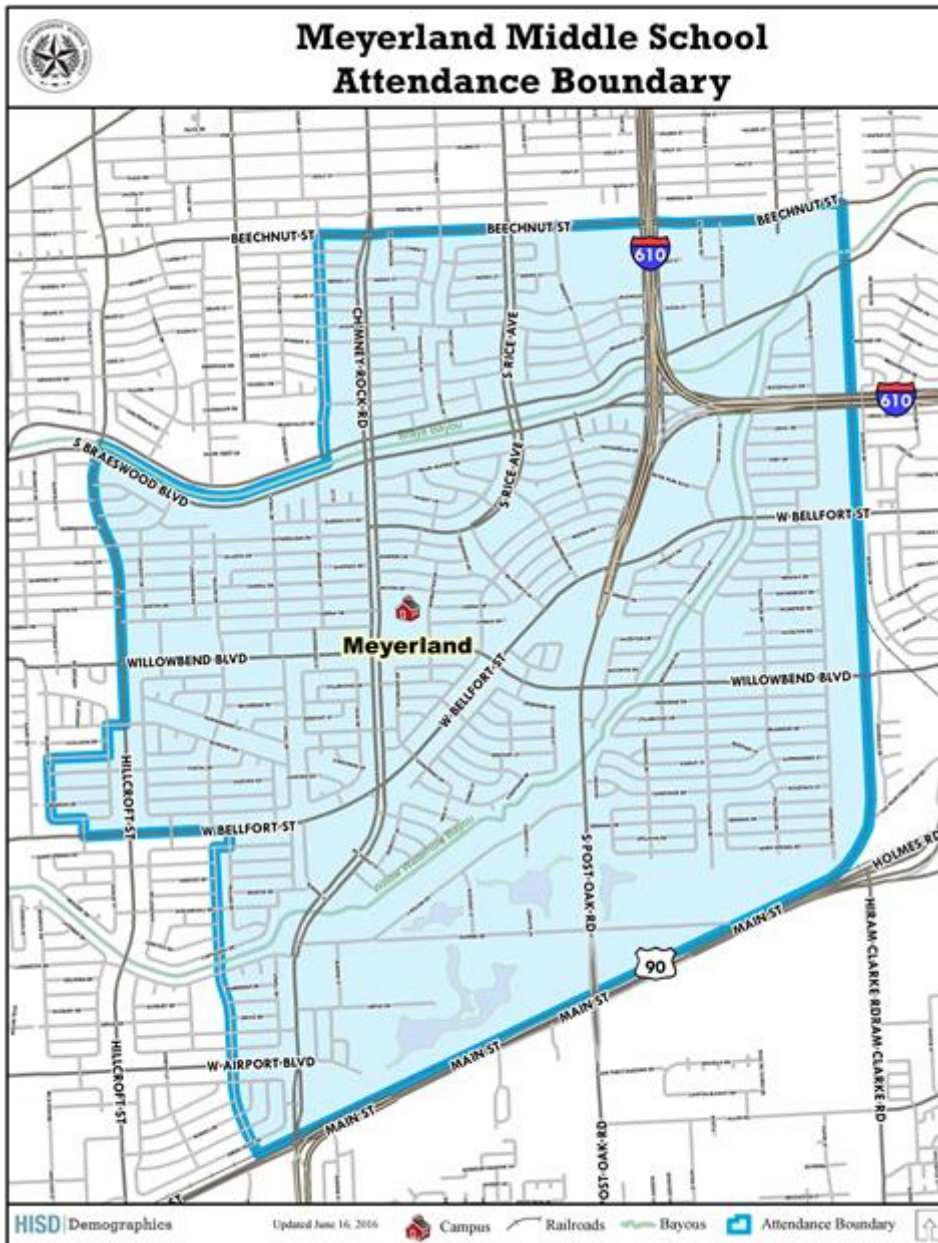

**NEW STUDENT REQUIRED ENROLLMENT DOCUMENTS**

**PLEASE READ:**

To enroll your student(s) at Meyerland PVA Middle School, the student must be zoned to Meyerland PVA MS or have an approved transfer to Meyerland PVA MS on file. Parent or legal guardian must have ALL required documents (lists provided below). Parent or legal guardian (as appointed by courts) must accompany the student at the time of enrollment. Legal documents must be provided in situations involving divorce and/or other legal guardianship. If you are unable to provide the necessary documents required during your appointment, you will be asked to reschedule.

If you are living with relatives or friends zoned to Meyerland PVA MS, you must complete and submit ALL of the following documents:

Statement of Residence:

- ENGLISH—MUST BE NOTARIZED
- SPANISH –MUST BE NOTARIZED

Student Assistance Questionnaire:

- ENGLISH
- SPANISH

Letter from zoned resident with the length of time student will be residing at the residence

Government/State Issued ID for both parent and zoned resident

Proof of Residency in the form of a utility bill, lease, deed—ZONED RESIDENT’S NAME MUST APPEAR ON PROOF DOCUMENT

Proof of Residency, in any form, with zoned address listed—PARENT’S NAME MUST APPEAR ON PROOF DOCUMENT

\* – f. Completed Shared Residency Affidavit (MUST BE NOTARIZED IF HISD-ZONED RESIDENT CANNOT BE PRESENT)
